REQUIREMENTS & CONDITIONS

Ozzy's Playhouse

Dogs must be at least 12 weeks old to attend camp.

Dogs over the age of 1 year must be spayed or neutered. Ozzy's Playhouse reserves the right to require your dog to be spayed or neutered based on behavioral evaluations before 1 year of age.

Dogs must present proof of current Rabies (over 4 months), DHPP and Bordatella, or titer equivalent, and keep Ozzy's Playhouse' files current with updated copies of all shot records on arrival at Ozzy's Playhouse.

Before a reservation is confirmed for camp, all dogs must pass a sociability screening. There is no charge for this evaluation. Owner must complete Client Information Sheet and sign our Client Consent Form prior to dog(s) arrival at Ozzy's Playhouse for camp.

Discount Packages are available for multiple days. If you choose to use one, it must be purchased in advance of your dog's stay at Ozzy's Playhouse. Discount packages are good for 6 months and are non-refundable.

Half Day Camp is up to 4 hours. More than 4 hours is considered Full Day Camp.

Baths:

We like to send your dog home to you clean. Ozzy's Playhouse will provide scheduled baths for your dog. Must be called at least 24 hours in advance. Please see price list below:

Small Dogs (under 35 pounds)

Short Hair: \$20 Long Hair: \$25

Medium Dogs (35 - 75 pounds)

Short Hair: \$30 Long Hair: \$40

Large Dogs (over 75 pounds)

Short Hair: \$45 Long Hair: \$50

*All dogs receive complimentary blueberry facial and ear cleanings.

Pick Up & Drop Off Times:

Monday - Friday: 6:00 am - 7:00 pm

Saturdays: 7:00 am - 5:00 pm

Sundays: Closed

All dogs must be picked up by 7 pm, or you will incur a \$25 late fee.

Camp is closed for pick up or drop off on all major Holidays (New Year's Eve, New Year's Day, July 4th, Memorial Day, Labor Day, Columbus Day, Thanksgiving and Christmas.)

We accept Cash, Check, Visa, MasterCard, American Express and Discover. Payment is due when your dog is dropped off or picked up unless other arrangements have been made or unless one of our discount packages has been purchased.

CLIENT CONTRACT

Ozzy's Playhouse

This contract is between Ozzy's Playhouse or its representatives ("OP") and the dog owner whose signature is below.

1. I certify that my dog(s) is in good health, has not been ill with any communicable diseases or parasites in the last 30 days, and has not harmed or shown aggressive or threatening behavior towards any person or any other dog.
2. I understand and acknowledge that OP is an open play environment and because of that there are inherent risks to my dog(s), which, even when monitored, may result in the following:
 - Transfer of a communicable illness such as, but not limited to bordatella (canine cough), parasites, conjunctivitis, or puppy warts.
 - Injuries, usually benign, such as broken nails, sore pads, minor puncture wounds, lacerations, abrasions and cuts, particularly in shorter coated breeds.
3. I assume the risk of any injury to my dog resulting from any of the inherent dangers and risks of the natural physical surroundings here at OP, including but not limited to; weather conditions, rocks, stumps, trees, gopher holes, collisions with natural objects and/or other dogs.
4. I acknowledge that OP will act in the best interest of me and my dog(s). OP will exercise all due and reasonable care to prevent injury or illness to my dog(s) and agrees to exercise due diligence and reasonable care to keep the premises safe, sanitary and properly enclosed.
5. In the event of injury or illness, I authorize OP to act in my behalf to obtain veterinary care, or other services, as necessary, and I agree to accept full financial responsibility for any and all expenses involved in such services.
6. I understand that I am solely responsible for any harm, including to other dogs, to the employees and invited guests of OP, caused by my dog(s) while attending OP, and agree to accept full financial responsibility for any and all expenses involved.
7. I agree to reimburse OP for destruction of OP facilities or OP equipment that OP considers above and beyond normal wear and tear.
8. I certify that each of my dog(s) is free of fleas and when brought to OP. If fleas or ticks are found on my dog, I agree to pay for appropriate flea and tick treatment for my dog.
9. I certify that my dog(s) is current on all required vaccinations when brought to OP for each visit. I understand it is my responsibility to keep all vaccination records updated with Ozzy's Playhouse. If the vaccinations for my dog(s) are not current upon arrival at camp, I authorize Ozzy's Playhouse to contact my vet of record for an updated shot record.

10. I certify that each of my dogs over the age of 1 year has been spayed or neutered. Ozzy's Playhouse reserves the right to require your dog to be spayed or neutered based on behavioral evaluations before 1 year of age.
 11. I understand that each of my dogs will be screened before being allowed into OP. If my dog(s) becomes too difficult to handle or too aggressive, creating the potential for harm to other dogs or people, I understand that OP maintains the right to refuse service or to discharge my dog(s) at any time.
 12. I agree to pay OP by cash, check, Visa, MasterCard or Discover at the end of my dog's stay.
 13. I give consent for my dog(s) to participate in water activities at the OP facility.
 14. I give Ozzy's Playhouse permission to photograph my dog while at Ozzy's Playhouse. In doing so, I give Ozzy's Playhouse permission to use such photos in their social media and website, brochures and other promotional material.
 15. I have read this contract and agree to abide by all of the above.
 16. I agree that any dispute arising under this contract or any interpretation required of or the enforcement of rights and duties under this contract shall be subject to final and binding arbitration pursuant to the American Arbitration Association ("AAA"). The award of the arbitrator(s) shall be enforceable according to the applicable provisions of the Rhode Island Code of Civil Procedure. The arbitrator(s) may award damages and/or permanent injunctive relief, but in no event shall the arbitrator(s) have the authority to award punitive or exemplary damages.

By signing this document, I acknowledge that OP, its owners and employees, will take every precaution to insure the safety and health of my dog while it is in their care. However, all dogs are left at OP entirely at my own risk. I agree to hold OP, its owners and employees harmless and free from any liability should my dog incur any injury or illness during his or her stay at OP.
